CONSENT FOR PROCESSING OF PERSONAL DATA

INITIAL INFORMATION

The CzechInvest Business and Investment Development Agency, registered office at Štěpánská 567/15, 120 00 Praha 2, ID no.: 71377999, state contributory organization (hereinafter as "CzechInvest"), hereby provides information on the basic principles and rules in compliance with the provision of Article 13 et seq. of Regulation no. <u>2016/679</u> of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive <u>95/46/EC</u> (hereinafter as "GDPR"), based on which CzechInvest as the controller of the personal data in connection with the implementation of the CzechLink StartUp project (hereinafter the "Project") handles the personal data of the participant in the Project (hereinafter the "Data Subject").

I. <u>PURPOSE OF AND LEGAL GROUND FOR PERSONAL DATA PROCESSING</u>

CzechInvest as personal data controller (hereinafter the "Controller") in connection with the establishment of a contractual relationship between CzechInvest and the participant in the Project processes and archives under the conditions and within the limits defined by valid legal regulations, in particular in compliance with the provision of Article 6(1)(a) and (b) GDPR, the personal data of the Data Subject for the following purposes:

- implementation of the Project and the provision of services to Project participants;
- keeping internal records on Project participants.

II. SCOPE OF PROCESSED PERSONAL DATA

The personal data of the data subjects are processed to the extent of: first name, surname, place of permanent residence (street and number, municipality, Post Code), place of actual residence (street, number, municipality, Post Code), phone number and e-mail.

III. PERIOD OF PROCESSING OF PERSONAL DATA

The personal data will be processed for a period necessary for the securing of mutual rights and obligations ensuing from the contract with the participant in the Project.

IV. CONTACT DATA OF CONTROLLER, AGENT AND DATA PROTECTION OFFICER

The Controller provides the Data Subject with the following contact data so that the Data Subject may contact the Controller:

V. INFORMATION ON RECIPIENTS AND INTENTION TO DISCLOSE INFORMATION

The Controller discloses the personal data provided by the Data Subject to the following natural or legal persons, public authorities or other entities (hereinafter as "Recipient"):



- for the purpose of implementing the Project the personal data will be disclosed to a Project participant interested getting in touch with some other Project participant. The personal data are only disclosed to the extent necessary for the achievement of the purpose for which they are disclosed
 - on the basis of an obligation imposed on the Controller by some other regulation.

VI. OTHER INFORMATION ON PROCESSING OF PERSONAL DATA

The personal data of the data subjects are processed by automated means in electronic form.

The personal data of the data subjects will not be processed by personal data processors.

The Data Subject has the right to ask the Controller for the provision of information on the processing of his or her personal data.

The Data Subject has the right to obtain from the Controller without undue delay the rectification of inaccurate personal data concerning him or her. Taking into account the purposes of the processing, the Data Subject has the right to have incomplete personal data completed, including by means of providing a supplementary statement.

The Data Subject has the right to obtain from the Controller the erasure of personal data concerning him or her without undue delay and the Controller has the obligation to erase personal data without undue delay where any of the grounds specified by the General Data Protection Regulation applies.

The Data Subject has the right to demand that the Controller restricts the processing of personal data in cases defined by the General Data Protection Regulation.

The Data Subject has the right to object to processing of personal data concerning him or her where the Controller processes the personal data on the following grounds:

- the processing is necessary for the performance of a task carried out in the public interest or in the exercise of official authority vested in the Controller,
- processing is necessary for the purposes of legitimate interests of the Controller or a third party,
- for the purposes of direct marketing,
- for scientific or historical research purposes or statistical purposes.

The Data Subject has the right to receive the personal data concerning him or her, which he or she has provided to the Controller, in a structured, commonly used and machine-readable format and has the right to transmit those data to another Controller without hindrance from the Controller in cases defined by the General Data Protection Regulation.

Where the processing of personal data is based on the personal data processing consent given by the Data Subject, such Data Subject has the right to withdraw this consent at any time.

If the Data Subject is of the opinion that legal regulations were infringed in connection with the protection of his or her personal data, the Data Subject has the right to lodge a complaint with a supervisory authority. The supervisory authority in the Czech Republic is the Office for Personal Data Protection.

The Data Subject gives the Controller consent for the processing of his or her personal data in accordance with the above-given information.
