
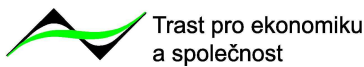


INVITATION TO WORKSHOP

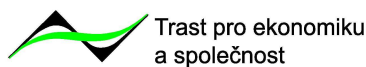
